### **MINUTES**

Pursuant to the Governor's Executive Order No. 20-003, a regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. on Tuesday, April 21, 2020, via video / telephone conference using Zoom. Present were Mayor Bob Roseland; Council Members: Roy Swenson, Michael Herzog, Kacie Murtha, Dan Craney. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held.

## Regular Agenda

**Agenda Item 1.** Mayor Roseland proclaimed Wednesday, April 22, 2020, as Earth Day in the City of Springfield. Motion by Swenson, seconded by Herzog, to approve the proclamation. Joslyn Stamp, 6<sup>th</sup> grade student with Green Bellevue, gave a speech about Earth Day and the work she has done to upcycle products and the recycling initiative she started at her school to recycle crayons and markers.

**Agenda Item 2.** Motion by Swenson, seconded by Murtha, to approve the bid from Neuvirth Construction in the amount of \$108,340.32 for construction services related to the City Park restroom facility project. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 3.** Motion by Swenson, seconded by Craney, to approve the bid from CXT Concrete Buildings via Sourcewell in the amount of \$147,355.00 for the purchase of a new restroom building for City Park. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 4.** Council discussed the city's existing water and sewer capacity and availability for future developments. Kathleen Gottsch, City Administrator, informed the Council that a developer has submitted applications for a future land use amendment, zone change and preliminary plat for an industrial / commercial development on the southwest corner of Hwy 50 and Platteview Road. It is estimated that this development will use the city's remaining 36,000 GPD of available sewer capacity. Council directed staff to proceed with developer negotiations to utilize the remaining sewer capacity.

**Agenda Item 5.** Brian Schuele, city engineer with Olsson, reviewed the proposal for engineering services related to the city-wide drainage project. New services include wetland delineation and Section 404 permitting.

Council Member Swenson introduced **Resolution 2020-12** and moved its adoption. Council Member Craney seconded the foregoing motion and on roll call on the passage and adoption of said resolution, the following voted YEA: Swenson, Herzog, Murtha, Craney. The following voted NAY: None. Whereupon the Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows:

# RESOLUTION 2020-12

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the City of Springfield, Nebraska, a Municipal Corporation, and Olsson, wish to enter into Contract Amendment #1 for engineering services rendered on City-Wide Drainage Improvements; and

**WHEREAS,** professional services provided by Olsson shall consist of wetland delineation and USACE Section 404 permitting.

**NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the City of Springfield, Nebraska that the Mayor is authorized to enter into Contract Amendment #1 attached hereto as Exhibit "A".
