Regular Agenda

Agenda Item 1. Motion by Herzog, seconded by Swenson, to move regular agenda item 1, regarding the Sarpy County Sheriff's Monthly Service Report, to later in the agenda upon arrival of a representative. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 2. Mayor Roseland proclaimed Thursday, April 22, 2021, as Earth Day in the City of Springfield. Motion by Swenson, seconded by Murtha, to approve the proclamation. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 3. Brian Schuele, city engineer with Olsson, reviewed 60% construction plans for the Main Street improvement project and Platteview Road overlay project. Main Street will be widened from 6th Street to 10th Avenue to match the roadway width to the west. Concrete curb and gutter and storm sewer will also be installed on Main Street. The city is coordinating with the elementary school to

minimize access issues. City staff is also working with the contractor at the new elementary school in order to align design with the driveway at the new school. Swenson inquired if the standing water issues at the intersections of 7th and 8th Street will be corrected. Schuele noted that the new roadway design should eliminate this issue. Surface water will drain to the street and into the storm water system as opposed to the ditches. Schuele reported that Platteview Road will be milled, repairs made as needed and an overlay completed from 5th Avenue to 2nd Street. Craney noted traffic concerns on Platteview Road. Schuele said he is still working on phasing for this project. He anticipates one lane being open at a time and said the project specifications will limit construction on Platteview Road to a small window, such as no more than one week. Construction will begin mid-June and last through the summer. The plan is to get the school area done before school starts back up in August.

Agenda Item 1. Sargent Potmesil reviewed the Sarpy County Sheriff's Report. He noted an uptick in overnight parking complaints. Herzog expressed concern over ATV and mini bike usage in town. Sargent Potmesil encouraged people to contact the sheriff's office when they see a violator. Swenson expressed concern with people passing in no passing zones on Platteview Road and 132nd Street. Council inquired if the county could put up no passing signs.

Agenda Item 4. Gene Graves, developer, noted that there appear to be three primary issues concerning the development of Springfield Pines Phase 2 now rather than when the Sewer Agency sewer system is available in 2024: (1) temporary sewer facility, (2) location of effluent discharge and (3) allowing the cost for the temporary sewer to be put into General Obligation debt. Joseph Foley, developer's engineer, reviewed the proposed operation of a temporary sewer facility and the possible locations for effluent discharge. Adam Flanagan, SID financial advisor, reviewed financial data for Phase 2 and how it would impact Phase 1. Graves asked if the Council was in favor of him proceeding with the development of Phase 2 now with a temporary sewer solution as opposed to waiting for the permanent system from the Sewer Agency. Craney said that he wants more development to come to Springfield and supports new development, but wants to hold off on this development until the Sewer Agency system is available. He is cautious about the proposed \$1.2 million temporary sewer solution and completely against any effluent discharge into the city's storm sewer system. Craney also noted that Graves' proposal includes combining the second phase with the current development and, therefore, the residents of the first phase essentially paying three times for sewer: (1) sewer fees for phase 1 development, (2) cost of temporary sewer solution and (3) fees to Sewer Agency. Flanagan noted that combining SIDs would lower the levy for phase 1 because the operational costs would even out over both phases. The additional valuation of phase 2 would help decrease the general fund levy. He said the park area could also be expanded with new amenities. Swenson reported that he researched the sewer treatment options provided and agrees with Craney. Herzog and Murtha also agreed with Craney's concerns. Flanagan inquired if the city would allow Graves to develop phase 2 concurrently with the Sewer Agency project. Craney said he is not against growth and likes Flanagan's proposal. Foley noted that Graves may get more competitive bids with a larger construction window if the project was run concurrently with the agency system. Graves will consider whether or not to continue planning for phase 2 in conjunction with the sewer agency system. No action was taken.

Agenda Item 5. Council directed city staff to advertise for a seasonal mower.

Department Reports

Agenda Item 1. Swenson reported that there was an issue with the sludge testing from 2018. Staff is working with Midwest Labs and NDEE to correct the issue.

Agenda Item 2. Herzog reported that Community Building rentals are increasing. He expressed concern with the condition of a particular building in the downtown district of Main Street. Kathleen Gottsch, City Administrator, said she asked the Sarpy County Building Inspector to inspect the exterior of the building and advise of building code violations. This item will also need to be addressed through the Board of Health.

Agenda Item 3. Murtha reported that the new stops signs are installed at the intersection of 8th and Elm Streets. The sand/salt enclosure is now complete. She mentioned concerns over when the burn pile is lit. Street repairs are ongoing.

Agenda Item 4. No Department Report from Craney.

Agenda Item 5. No Department Report from Mayor Roseland.

Agenda Item 6. Gottsch reported that the Springfield Days Committee asked for direction for this year's event. Council said the organization could proceed with activities. The committee is planning a street dance, fireworks, parade, food trucks and the SYAA's Color Run. Other activities may be planned.

Adjournment

Motion by Herzog, seconded by Swenson, to adjourn. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Meeting adjourned at 8:34 p.m. Motion carried.
