## Regular Agenda

**Agenda Item 1.** Lt. Core reviewed the Sarpy County Sheriff's monthly service report. He discussed speeding vehicle enforcement, parking tickets and response times.

Agenda Item 2. A Public Hearing of the Springfield City Council was opened at 7:08 p.m. to consider a final plat application filed by DAMMM Land, LLC, applicant, and RTR Development, LLC, owner, on property legally described as the North ½ of the Northeast ¼ of Section 23, Township 13 North, Range 11 East of the 6<sup>th</sup> P.M., Sarpy County, Nebraska; and generally located on the southwest corner of Hwy 50 and Platteview Road (Lots 1-4 and Outlots A & B, Springfield Commerce). Council reviewed the staff report and comments provided by city professional staff. Kathleen Gottsch, City Administrator, reported that several items were still not complete, including the subdivision agreement and final plat revisions, and, thus city professional staff and the developer's team were requesting that this item be tabled until the next Council meeting. Jon Meyers, MADDAD Land LLC (previously DAMMM Land LLC), developer, informed the Council that he has had the land under contract since January and has since gone beyond his due diligence period. He said he has agreed to the reduced sewer capacity of 24,000 gallons and to generate only domestic strength waste. He noted that he has been in the warehouse business for forty years and operates under Cannonball Express, Nebraska Warehouse, etc. Gottsch informed the Council that city staff and the developer had come to an impasse regarding the allocation of payment for sewer capital facilities fees and the SID's debt ratio and, thus, the Council's direction on city policy was needed in order to move forward. Meyers said that the project is split into two phases because the city can only provide him sewer capacity for phase 1. If financials for both phase were combined, the project's debt ratio would be under the city's requested 4%; however, staff was reluctant to tie phase 2 into the agreement. Financials for phase 1 show the project's debt ratio at 5.01%. Both scenarios include 25% of the sewer capital facilities fees as being generally obligated. Meyers noted that capital facilities fees cannot all be 100% allocated to special assessments because it drives up the price of the lots. Jeff Farnham, attorney for developer, said the focus is on the project as a whole. He said that velocity and value are what makes an SID go. Timing is important to the tax value and paying down the debt. Farnham reviewed policies from other cities regarding debt ratios. He pointed out that Meyers plans to grade the entire project, not just phase 1, which shows commitment to the whole project. Doug Kellner, developer's engineer with TD2, noted that a lot of the project costs are being charged up front in phase 1 such as turn lanes onto Hwy 50 and Platteview Road, larger storm sewer at the bottom of the hill, and traffic light. Bill Seidler, Jr., City Attorney, questioned as to how long it would take for the city to be able to annex the development. If the development costs too much, then it could block future westward annexation by the city. Meyers said that D.A. Davidson has recommended the levy be set at 1.00. Gottsch noted that the Council could accept the higher debt ratio on only phase 1 if the levy is set at 1.00 minimum each year until such time as the city annexes the subdivision. Council indicated that they were accepting of that arrangement. No one else from the public spoke in favor of or in opposition to the application. Motion by Herzog, seconded by Murtha, to continue the public hearing until the August 18, 2020, Council meeting. AYES: Herzog, Murtha, Craney. NAYS: None. Motion carried. Public hearing ended at 8:07 p.m.

**Agenda Item 3.** Motion by Murtha, seconded by Herzog, to table agenda item 3, regarding consideration of approval of Resolution 2020-26 approving the Subdivision Agreement and Final Plat of Lots 1-4 and Outlots A and B, Springfield Commerce, until the August 18, 2020, Council meeting. AYES: Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 4.** Steve Zink, 485 South 2<sup>nd</sup> Street, requested a hearing before the City Council to appeal the city's direction for him to remove a dead tree within the right-of-way on his property. Zink was

unable to attend the hearing in person, but submitted email correspondence to the city requesting the city pay for one-half of the cost to remove the dead tree. Council reviewed the city ordinance and procedure for removal of a dead tree and considered Mr. Zink's request. Motion by Murtha, seconded by Craney, to deny Mr. Zink's request that the city pay for one-half of the cost to remove the dead tree on his property at 485 South 2<sup>nd</sup> Street. AYES: Murtha, Craney. NAYS: Herzog. Motion carried.

**Agenda Item 5.** Motion by Murtha, seconded by Herzog, to table agenda item 5, regarding concrete paving saw bids, until the August 18, 2020, Council meeting. AYES: Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 6.** Council considered bids for the construction of a roof on the salt/sand storage bay at the maintenance facility. Staff reported that the materials were already purchased for the project. Council directed city staff to construct the roof.

**Agenda Items 7 and 8.** Motion by Herzog, seconded by Murtha, to move agenda items 7 and 8, regarding Rick Lee and Andie Ledenbach's annual reviews, into executive session. AYES: Herzog, Murtha, Craney. NAYS: None. Motion carried.
