Regular Agenda

Agenda Item 1. Lt. Matt Core reviewed the Sarpy County Sheriff's monthly service report. Council requested that law enforcement ticket overnight parking violators.

Agenda Item 2. Motion by Herzog, seconded by Swenson, to proclaim January 26 through February 1, 2020, as School Choice Week. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 3. Craig Reinsch, City Water Engineer with Olsson, reviewed the plans and specifications for the proposed well project and outlined the project history. He noted the plans were submitted to NEDHHS and he is working through a comment letter recently received from their office. Since the last nitrate test was taken in 2015, the state and Reinsch recommend the city conduct another water quality sampling prior to well drilling. Council requested a bid from Layne be obtained for such services. Reinsch also noted that the right-of-way permit from NDOT was approved for the project. He also delivered the building permit application to city staff. Reinsch reported that the bid climate is high in the metro area right now. The new project cost estimate is \$1.6 million, which includes the well, well house, and main extensions. He noted that the SRF loan agreement will need to be amended after the

bid process. Council discussed the Springfield Cemetery Association's opposition to the well project and denial of an access road. Reinsch reviewed a possible access road option through SSAP's property, as per SSAP's future master plan expansion. Council discussed wellhead protection ordinances. Council requested staff arrange another meeting with cemetery board members giving them the choice of either attending a future Council meeting or meeting with two Council representatives in a private meeting. No action taken on bid plans and specifications.

Agenda Item 4. Council Member Swenson introduced Resolution 2020-1 and moved its adoption. Council Member Herzog seconded the foregoing motion and on roll call on the passage and adoption of said resolution, the following voted YEA: Swenson, Herzog, Murtha, Craney. The following voted NAY: None. Whereupon the Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows:

RESOLUTION 2020-1

Nebraska Department of Transportation Municipality Financial Agreement

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska, as follows:

WHEREAS, the City of Springfield, Nebraska, a Municipal Corporation, and the State of Nebraska Department of Transportation, wish to enter into a Municipality Financial Agreement for State Projects for the purpose of improving a portion of State Highway N-50 at the intersection of Platteview Road; and

WHEREAS, the State intends that the improvement be developed and constructed under the designation of Project No. STP-50-2(136); and

WHEREAS, the improvement is located within the designated urban area of Springfield and funds administered by the State will be made available for the construction of this project; and

WHEREAS, the highway improvement costs will be split as outlined in the agreement between the Surface Transportation Program, State and Municipality; and

WHEREAS, Springfield's cost of the project will be the sum of 26% of all the preliminary engineer and construction engineering on the project, 50% of construction costs and 50% of utility costs; and

WHEREAS, this Agreement is related to the portion of the project on State Highway N-50 located within Springfield's corporate limits; and

WHEREAS, this Agreement outlines certain roles and responsibilities of the State and Municipality applicable to this project; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska that the Mayor is authorized to enter into the Municipality Financial Agreement for State Projects attached hereto as Exhibit "A."

Introduced and Passed this 7th day of January, 2020.
