Regular Agenda

Agenda Item 1. Lt. Matt Core reviewed the Sarpy County Sheriff's monthly service report. He said the department is addressing vehicle parking complaints and watching the level of the river for potential flooding.

Agenda Item 2. Andrew Rainbolt, Sarpy County Economic Development Corporation, provided the Annual Return on Investment report. He noted that the corporation has an option on one 80 acre site in Springfield's jurisdiction and is also submitting projects for the Springfield Commerce development.

Agenda Item 3. Melvin Green, Finance Officer for the Springfield American Legion, disputed the water billing charge for the months of August 2020 and January 2021 for the Legion Hall located at 166 South 2nd Street. Council reviewed utility billing consumption history for the property. In March 2020 the Legion installed a new meter at this location because the previous meter had stopped working and was not reading water usage. The Legion had been billed minimums for the entire time the meter was not working. Green said that in March 2020 the Legion closed the building due to COVID-19 precautions and was reopened later in the year. During the months of April through July 2020 there was no meter read. Then in August 2020 the location had a read of 23,000 gallons of water. For the next three months, there was again no read until December 2020 at which time the meter read 1,000. Then in January 2021, the meter read 23,000. In February 2021 the Legion replaced the meter again because they felt it was not working properly. Green requested the city refund the Legion the difference between the minimum bills and the two higher reads in August 2020 and January 2021. Swenson informed Green that when a meter quits working it doesn't read high. In fact it stops reading altogether, like what happened to their meter in 2018 and 2019, or it under reports usage. Green said members of the Legion have checked for leaks and found nothing. They have not hired a plumber to investigate. Swenson said that city staff is researching ways to test water meters. Green will return the meter to City Hall and the city will research testing options. No action was taken.

Agenda Item 4. Patrick Sullivan, attorney for the Sarpy County Agricultural Society, reviewed the 2008/2009 land exchange between the city and Ag Society. He noted that the Ag Society thought they already owned Lot 7A1 and the county assessor actually had them listed as the owner. It wasn't until the sewer agency did a title search on the property that they discovered that the city was still actually the owner. Swenson noted that no city funds have been spent on that property over the last 12 years. Bill Seidler, Jr., city attorney, said that the Ag Society had previously given the city a permanent easement on this property for the trail, so that will need to be redone once ownership is exchanged. A temporary easement must also be granted to the sewer agency for sewer trunk main construction. Sullivan and Seidler will prepare documents to complete the land exchange. The city will need to adopt a resolution to sell the property and outline exchange contingencies such as the permanent trail easement and temporary sewer easement.

Agenda Item 5. City staff reviewed the overlay building plans for Lot 1, Springfield Commerce and noted a few non-conforming items. The developer was notified and the city is still waiting to receive the revised documents from the developer. Motion by Swenson, seconded by Herzog, to table agenda item 5, regarding approval of the Highway Corridor Overlay District and Overlay District Design Review for Lot 1, Springfield Commerce, until the March 16, 2021, Council meeting. AYES: Swenson, Herzog, Murtha. NAYS: None. ABSENT: Craney. Motion carried.

Agenda Item 6. Motion by Swenson, seconded by Herzog, to approve the Main Street Overlay District Design Review for Lot 1, Springfield Elementary. AYES: Swenson, Herzog, Murtha. NAYS: None. ABSENT: Craney. Motion carried.

Agenda Item 7. Council reviewed photos and details of erosion occurring along Springfield Creek north of Platteview Road. The city engineer is working with Neuvirth Construction, the contractor working on other erosion repairs along the creek, to obtain a cost estimate. Motion by Swenson, seconded by Herzog, to authorize city staff to approve additional work pending input from the city engineer. AYES: Swenson, Herzog, Murtha. NAYS: None. ABSENT: Craney. Motion carried.

Agenda Item 8. Kent Maystrick, city street superintendent, reported that a wing wall was needed on the west side of the culvert project at the city's maintenance facility. Brian Schuele, city engineer with Olsson, obtained Change Order No. 1 from TJ Osborn Construction for this additional work. Motion by Swenson, seconded by Murtha, to approve Change Order No. 1 in the amount of \$13,500 for the addition of a wing wall as part of the city-wide drainage improvement project. AYES: Swenson, Herzog, Murtha. NAYS: None. ABSENT: Craney. Motion carried.

Agenda Item 9. Council Member Murtha introduced Resolution 2021-8 and moved its adoption. Council Member Swenson seconded the foregoing motion and on roll call on the passage and adoption of said resolution, the following voted YEA: Swenson, Herzog, Murtha. The following voted NAY: None. The following were ABSENT: Craney. Whereupon the Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows:

RESOLUTION 2021-8

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, as per Springfield Municipal Code §5-211 "Signs; Signals," the Mayor and City Council hereby direct the Springfield Street Department to:

- (1) remove the yield sign on northbound North 7th Street at the intersection of Elm Street
- (2) place a stop sign on northbound North 7th Street at the intersection of Elm Street
- (3) place a stop sign on eastbound Elm Street at the intersection of North 8th Street
- (4) place a stop sign on northbound North 8th Street at the intersection of Elm Street

WHEREAS, the streets listed herein are located within the corporate limits of the City of Springfield; and

WHEREAS, a map is attached hereto as Exhibit "A" depicting the location of the traffic signs.

Agenda Item 2. Herzog reported that the library is preparing for new carpet installation.

Agenda Item 3. Murtha and Maystrick reported that the street department has begun street repairs. They will be repairing alleys and chasing cracks in the near future. Maystrick noted that city staff will also soon begin fixing parking lots.

Agenda Item 4. No Department Report from Craney.

Agenda Item 5. Mayor Roseland reported on upcoming sewer agency meetings. He noted he is helping a local business with a promotional video.

Agenda Item 6. Kathleen Gottsch, City Administrator, reported that staff is in the process of scheduling cleanup day for spring 2021. She provided an update on the city-wide drainage project and noted that an adjacent property owner to where the improvements are being done south of 6th and Mulberry was upset about trees being removed from the right-of-way and drainage easement. Council considered adding new trees to the project but couldn't agree to move forward with planting new trees, so a change order will not be issued for new tree plantings. Gottsch also reported on upcoming special Council meeting dates to finalize the annexation of Lots 1-3, Gemini.
