Regular Agenda

Agenda Item 1. Lt. Matt Core reviewed the Sarpy County Sheriff's monthly service report. Herzog requested that the sheriff's department monitor 132nd Street from Platteview Road north to Hwy 50 for speed and passing violators.

Agenda Item 2. Motion by Swenson, seconded by Craney, to table agenda item 2, regarding options for city-wide drainage improvements, until the March 17, 2020, Council meeting. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 3. Council reviewed the site plan for the new restroom facility at City Park, confirmed upgrade options and reviewed associated costs. Kathleen Gottsch, City Administrator, discussed project budget and outlined the bid phase process.

Agenda Item 4. Motion by Craney, seconded by Swenson, to approve the bid from Langfeldt Overhead Door in the amount of \$1,885.00 for the installation of a new concession stand window at Buffalo Park. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 1. Swenson reported that he attended a meeting regarding transportation bus services between Omaha and Lincoln.

Agenda Item 2. Herzog reported that the library's chili cook-off was a success. He reported that the library furnace continues to have issues, so a new unit may be necessary. Gottsch reported that the maintenance department has begun painting the lower level restrooms at the Community Building.

Agenda Item 3. Murtha reported that the maintenance department patched alleys from winter damage. The new street signs are in and will be installed soon. The street sweeper will be in town this week. Murtha noted that Kent Maystrick Street Commissioner, is obtaining quotes for mudjacking in various locations. Maystrick is also prepping the site for the construction of a new material bay.

Agenda Item 6. Gottsch reported that the legion baseball program plans to remove the fence around the batting cage at Buffalo Park. The safety net will remain in place.
