### **MINUTES**

A regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. at City Hall on Tuesday, May 18, 2021. Present were Mayor Bob Roseland; Council Members: Roy Swenson, Michael Herzog, Kacie Murtha, Dan Craney. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held.

**Agenda Item 1.** Josh Charvat with the Sarpy County Economic Development Corporation reviewed the 1<sup>st</sup> quarter report.

**Agenda Item 2.** Motion by Swenson, seconded by Craney, to approve the Highway Corridor Overlay District Design Review for Turner Construction's contractor office building on Lot 1, Gemini. AYES: Swenson, Herzog, Murtha, Craney. NAYS: None. Motion carried.

**Agenda Item 3.** Council reviewed the bid tabulation prepared by Brian Schuele, city engineer with Olsson. Omni Engineering was the only contractor to bid. Their bid was in the amount of \$1,005,706.45 for both the Main Street and Platteview Road projects. The engineer's cost estimate for both projects was \$724,036.71. The city attorney noted that as per Neb. Rev. Stat. 17-568.01, if fewer than two bids are received or if the bids received contain a price that exceeds the estimated cost, the Mayor and Council may negotiate a contract in an attempt to complete the proposed projects at a cost commensurate with the estimate given. Motion by Swenson, seconded by Herzog, to direct city staff and the city engineer to negotiate a contract on the Main Street and Platteview Road Improvements Projects. ## RESOLUTION APPROVING THE FIRST AMENDMENT TO SARPY COUNTY AND CITIES WASTEWATER AGENCY FY2020-2021 BUDGET

WHEREAS, City of Springfield is a party to an interlocal agreement (as amended, the "<u>Formation</u> <u>Interlocal</u>") entered into pursuant to the Interlocal Cooperation Act, set out at Neb. Rev. Stat. § 13-801 et seq., by and between Sarpy County and the Cities of Papillion, Bellevue, Springfield, La Vista and Gretna (the "<u>Members</u>"), which formed the interlocal agency called the Sarpy County and Cities Wastewater Agency (the "<u>Agency</u>");

WHEREAS, pursuant to Section IX of the Formation Interlocal, the Agency Board is required to approve an itemized annual budget which shall be presented to and subject to approval of the individual governing body of each Member;

WHEREAS, pursuant to Agency Resolution No. 2020-007, the Agency Board previously approved the Sarpy County and Cities Wastewater Agency FY2020-2021 Budget (the "<u>FY2020-2021 Budget</u>"), and the Governing Body of the City of Springfield subsequently approved the FY2020-2021 Budget;

WHEREAS, pursuant to Agency Resolution No. 2021-008, the Agency Board approved the First Amendment to the FY2020-2021 Budget (the "<u>Amended FY2020-2021 Budget</u>"), a copy of which is attached hereto as **Exhibit A**; and

WHEREAS, the Governing Body of the City of Springfield deems it appropriate and advisable to approve the proposed Amended FY2020-2021 Budget which has been approved by the Agency Board and is attached hereto as **Exhibit A**.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF SPRINGFIELD that the proposed Amended FY2020-2021 Budget is hereby approved.

## RESOLUTION APPROVING THE SARPY COUNTY AND CITIES WASTEWATER AGENCY PROPOSED FY2021-2022 BUDGET
