MINUTES

Pursuant to the Governor's Executive Order No. 20-003, a regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. on Tuesday, May 19, 2020, via video / telephone conference using Zoom. Present were Council Members: Roy Swenson, Michael Herzog, Kacie Murtha, Dan Craney. Absent: Mayor Roseland. Swenson, Council President, presided as Mayor. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was

communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. The Mayor publicly stated to all in attendance that a current copy of the Nebraska Open Meetings Act was available for review and indicated the location of such copy posted in the room where the meeting was being held.

Consent Agenda

Motion by Herzog, seconded by Murtha, to approve the Consent Agenda. AYES: Herzog, Murtha, Craney. NAYS: None. Motion carried.

Regular Agenda

Agenda Item 1. Shane Ehrke, on behalf of the Springfield Youth Athletic Association, reported that one 14 and under baseball team and one 13 and under baseball team would like to play this year. The 13 and under team would play at City Park and the 14 and under team would play at Buffalo Park. They will have approximately eight games and play teams from the Omaha metro area. The last game will be played July 30. They have parent volunteers to clean dugouts and restrooms. Players will sign waivers and fans will be limited and spaced out. Craney stated that he was not comfortable opening the ball fields yet. He said that there is still close contact in baseball and he is concerned that parents will not follow the social distancing guidelines. He reminded everyone that case numbers are still peaking in our area. Craney also expressed concern with keeping restroom facilities clean. Chad Metzer, Springfield Baseball Association President, said that they will have a volunteer manning each bathroom at Buffalo Park. The restroom will be cleaned after each use and ground markings will be used to keep people waiting in line at least 6' apart. They will install temporary fencing around the backstop and dugouts for players. The group will follow the guidelines issued by the Governor and will exceed the requirements in some regards. Players will bring their own chairs to sit in. Bleachers cannot be used because of cleats. The Legion teams plan to play approximately 30 games, including hosting two tournaments. Their last game will be August 5. Craney noted that he coached wrestling for many years and understands the desire to play; however, he questioned if the competition was worth it during this time. Murtha inquired as to what the consequences would be for players, coaches or parents breaking the rules and not adhering to the guidelines. Metzger said that the guidelines will be followed and a parent volunteer will be in each dugout to help players follow the rules. Bill Seidler, Jr., city attorney, reported that the League of Nebraska Municipalities is drafting documents for cities to use, if they so choose, for ball field usage. Gottsch inquired if the Legion had been able to obtain new insurance, since the National Legion Association was not sponsoring the season. Metzger said they are obtaining quotes for insurance coverage and will submit it to the city upon receipt. Jim Lynam, Springfield Baseball Association, asked if practices could begin June 1. Seidler noted that practices cannot begin until all legal documents are in place, if the Council allows the ball fields to open. Dan Babe, Springfield Baseball Association, said their association is also using uniform waivers.

RESOLUTION 2020-17

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska, as follows:

WHEREAS, the City of Springfield, Sarpy County, Nebraska and the County of Sarpy, Nebraska wish to enter into an Interlocal Cooperation Agreement outlining the terms and conditions for the construction and funding of future public road infrastructure improvements to Capehart Road, Fairview Road and 156th Street; and

WHEREAS, the City of Springfield, Sarpy County, Nebraska, and the County of Sarpy, Nebraska, are political subdivisions, duly created and validly existing under the laws of the State of Nebraska; and

WHEREAS, the Interlocal Cooperation Act, Neb. Rev. Stat. §13-801, et. Seq., authorizes cities and counties to cooperate on the basis of mutual advantage to thereby provide for services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of the local communities; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska, by a majority vote resolved that the Mayor of the City of Springfield shall have the authority to sign said Interlocal Cooperation Agreement in the form of attached Exhibit "A" which is incorporated by reference.

RESOLUTION 2020-18

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SPRINGFIELD, NEBRASKA APPROVING THE SECOND AMENDMENT TO SUBDIVISION AGREEMENT FOR LOTS 1 AND 2, COCKERILL ADDITION REPLAT 2, SARPY COUNTY, NEBRASKA.

WHEREAS, on January 16, 2018, the City Council of the City of Springfield approved Resolution 2018-1 (1) authorizing the Mayor to enter into a Subdivision Agreement with Barbara Cockerill, owner and subdivider of Cockerill Addition, and (2) approving a final plat (Lots 1-3, Cockerill Addition) of a subdivision located in Tax Lots D, 1 and 3, all in the Southwest Quarter of Section 30, Township 13 North, Range 12 East of the 6th P.M., Sarpy County, Nebraska, consisting of approximately 147.87 acres, more or less, and generally located at 17301 South 132nd Street; and

WHEREAS, on July 17, 2018, the City Council of the City of Springfield approved Resolution 2018-20 authorizing the Mayor to enter into the First Amendment to Subdivision Agreement with Barbara Cockerill, owner of Lot 4 Cockerill Addition Replat 1, Kildow Construction, Inc., owner of Lot 3 Cockerill Addition Replat 1, and John and Lisa Williams, Jr., owner of Lot 1 Cockerill Addition Replat 1; and

WHEREAS, the parties wish to amend the Subdivision Agreement for Lots 1-3, Cockerill Addition, which was filed with the Sarpy County Register of Deeds as Instrument No. 2018-02247 on January 30, 2018 and the Amended Subdivision Agreement for Lots 1-5, Cockerill Addition Replat 1, which was filed with the Sarpy County Register of Deeds as Instrument No. 2018-18496 on August 8, 2018, for the purpose of amending the lot size and lot lines of proposed Lots 1 and 2, Cockerill Addition Replat 2.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Springfield hereby approves and authorizes the Mayor to enter into the Second Amendment to Subdivision Agreement with Barbara Cockerill, owner of Lot 4, Cockerill Addition Replat 1 that will become Lot 2, Cockerill Addition Replat 2, and Kildow Construction, Inc., owner of Lot 3 Cockerill Addition Replat 1 that will become Lot 1, Cockerill Addition Replat 2, a copy of which is attached hereto as Exhibit "A."
