Present were Mayor Bob Roseland; Council Members: Mike Neitzel, Michael Herzog, Kacie Murtha, Dan Craney. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Regular Agenda

Agenda Item 1. Jessica Buckland & Nicholas Bender, 17777 Olive Street, Omaha, NE 68136, addressed the Council, requesting to rent the vacant lot west of the Community Building for their outdoor wedding ceremony. They have rented the Community Building for their wedding reception and would like to have an outdoor wedding ceremony. They are expecting approximately 150 people to attend. They will rent chairs to be placed on the property, as well as an arch and have an aisle runner. The event will be no more than three hours in length. No food or drink will be served at the ceremony. Right after the ceremony they will have all items removed from the vacant lot before the reception begins. Motion by Neitzel, seconded by Herzog, to direct staff to amend the rental agreement and insurance requirement to allow the rental of the vacant lot along with a Community Building rental. Agenda Item 2. Keegan Kulm, 13535 Buffalo Road, Springfield, explained that his rental property at 360 Elm Street, Springfield, had a water pipe break in December 2023. With this being one of the months used to calculate the sewer average rate for the year, Kulm asked to have his sewer average for this property recalculated with three months that more accurately reflect the actual usage on the property. Motion by Neitzel, seconded by Herzog, to adjust the new sewer average to a rate using a month prior to the water pipe break for calculating the sewer average rate for the property at 360 Elm Street. Agenda Item 3. Council Member Murtha introduced **Resolution 2024-9** and moved its adoption. Council Member Craney seconded the forgoing motion and on roll call on the passage and adoption of said resolution, the following voted AYES: Neitzel, Herzog, Murtha, Craney. RESOLUTION 2024-9

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the Cities of Springfield, Bellevue, Gretna and Papillion, Nebraska; County of Sarpy, Nebraska; and the Papio-Missouri River Natural Resources District, wish to enter into an Interlocal Cooperation Agreement for the continuation of the Southern Sarpy Watershed Partnership; and

WHEREAS, in 2015 the Sarpy Southern Ridge Wastewater Treatment Study was commissioned and identified areas of new development in Sarpy County that were not currently covered by a Watershed Management Plan; and

WHEREAS, in 2019 the Southern Sarpy Watershed Partnership was formed through an Interlocal Cooperation Act Agreement dated July 1, 2019, and expiring on June 30, 2024; and

WHEREAS, the members of the Partnership wish to continue to act in concert by proposing, enacting, and implementing common standards for development and addressing federally-imposed requirements and mandates which are imminent and which must be funded locally.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska that the Mayor is authorized to enter into the Interlocal Cooperation Agreement for the continuation of the Southern Sarpy Watershed Partnership, a copy of which is attached hereto as Exhibit "A."

Department Reports

Agenda Item 1. Neitzel reported that Heath Shemek, Water and Sewer Operator, will be working on the lead pipe inventory project due to the federal mandates.

Agenda Item 2. Herzog reported the library programs are coming along. He would like to see if the ceiling in the community building can handle the weight of sound deafening baffles to help with the acoustics upstairs.

Agenda Item 3. Murtha reported Tyler Holdorf, Parks Director, is fixing up the parks for the summer. We are still waiting for the delivery of the new shade sails for the splash pad. Holdorf, Jason Iverson, Maintenance Department, and Chris Woodman, Director of Buildings, Vehicles & Equipment, are discussing actions on the soccer complex.

Agenda Item 4. Craney reported that Bryan Cherry, Street Commissioner, is concerned about street repairs being completed with the pot holing lead pipe inventory project deadline. He will prioritize his list of repairs and work them as time and weather allows.

Agenda Item 5. Mayor Roseland reported that he signed letters of support for the SCCWWA requesting federal funds for the construction of a sewer trunkline west towards Gretna.

Agenda Item 6. Gottsch reported that SYAA found used astroturf for the batting cages. We will split the cost three ways between the city, SYAA and Springfield Platteview Schools. Holdorf raked the large rock from the batting cages and tamped down the smaller rock to prepare the area for the installation of the turf.
