Consent Agenda Item 6. Erin Deming, Blue Rose Charity Rodeo Board Secretary, thanked the Council for their support. Deming reported that this year they will have two bands playing at the event. Friday afternoon will feature a rodeo centered around kids with special needs.

Agenda Item 1. Cpt. Tori Boldt reported the Sherriff's Department has been focusing on traffic at Hwy 50 and Platteview Road, especially red light runners and speeders south of the intersection. The group home has had a few more calls in October with new residents and adjustment issues. Neitzel asked how much time is spent on an average call at the group home. Cpt. Boldt stated that it depends on the need (i.e. medical, new client, etc.). Defusing a situation may take only a few minutes, while removal of a person from the location could require two hours or more. The Sherrif's Department is looking forward to the Shop

with a Cop event in December. If anyone would like to nominate a family to participate in the event that is struggling financially or dealing with adversity, they are welcome to do so. Last year, over 100 children participated in the event. Cpt. Boldt invited everyone to the West Precinct Ribbon Cutting Ceremony on November 25 at 9 a.m. Neitzel asked how staffing will work at the new precinct. Cpt. Boldt stated that the normal hours of operation at the West Precinct will be Monday – Friday, 8 a.m. – 4 p.m. There is a button that will reach the other precinct when the office is closed.

Agenda Item 2. A Public Hearing of the Springfield City Council was opened at 7:11 p.m. to consider an application for a text amendment filed by Dave and Jane Jensen, 710 Main Street, Springfield, NE to amend Springfield Zoning Ordinance Article 4 General Provisions, Section 4.14 Accessory Building and Uses, Subsection 4.14.09 to revise the maximum allowable size of a detached garage based on lot size in the R-92, R-87, R-50, R-30, and RB Residential Districts. Dave Jensen, 710 Main Street, stated that he currently has a two-car garage with a concrete pad on the side. This has worked for them for 20 years. After retirement he purchased a boat with the intention of obtaining a building permit to add a third stall to the existing garage. It was then that he was informed that his existing garage was at the maximum allowable size for the size of their lot. Jensen is requesting an amendment to the existing zoning ordinance to allow residents with larger lots the ability to increase the maximum allowable size of an accessory structure square footage. Jeff Kallhoff, 12904 North Shore Drive, asked if this change would be for everyone or just the Jensen's. Kathleen Gottsch, City Administrator, stated that a text amendment change is for everyone, noting that the maximum impervious coverage would also need to be met. After all those wishing to speak were offered an opportunity to be heard, the Mayor recommended the hearing be closed. Motion by Herzog, seconded by Neitzel, to close the public hearing. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried. Public Hearing closed at 7:19 p.m.

Agenda Item 3. Council Member Murtha introduced Ordinance No. 1214 entitled:

AN ORDINANCE TO AMEND ARTICLE 4 "GENERAL PROVISIONS", SECTION 4.14 "ACCESSORY BUILDING AND USES" OF THE ZONING ORDINANCE OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA TO REVISE SUBSECTION 4.14.09 TO REVISE THE MAXIMUM ALLOWABLE SIZE OF A DETACHED GARAGE BASED ON LOT SIZE IN THE R-92, R-87, R-50, R-30 AND RB RESIDENTIAL DISTRICTS; TO REPEAL ORDINANCES IN CONFLICT; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF

and moved that the statutory rule requiring reading on three different days be suspended. Council Member Neitzel seconded the motion to suspend the rules and upon roll call vote on the motion the following Council Members voted AYE: Neitzel, Herzog, Murtha. The following voted NAY: None. The following were ABSENT: Craney. The motion to suspend the rules was adopted by three-fourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. Said ordinance was then read by title and thereafter Council Member Murtha moved for final passage of the ordinance, which motion was seconded by Council Member Nietzel. The Mayor then stated the question "Shall Ordinance No. 1214 be passed and adopted?" Upon roll call vote, the following Council Members voted AYE: Neitzel, Herzog, Murtha. The following voted NAY: None. The following were ABSENT: Craney. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor in the presence of the Council signed and approved the ordinance and the Clerk attested the passage and approval of the same and affixed her signature thereto and ordered the ordinance to be published or posted as required by law and as provided therein. A true, correct and complete copy of said ordinance is as follows:

ORDINANCE NO. 1214

AN ORDINANCE TO AMEND ARTICLE 4 "GENERAL PROVISIONS", SECTION 4.14.09 ACCESSORY BUILDING AND USES OF THE ZONING ORDINANCE OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA; TO REPEAL ORDINANCES IN CONFLICT; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA:

Section 1. Approval of Amendment to Zoning Ordinance. On October 14, 2025, the Springfield Planning Commission conducted a public hearing on the matter of amending Section 4.14.09 of the zoning ordinance to revise the maximum allowable size of a detached garage based on lot size in the R-92, R-87, R-50, R-30, and RB Residential Districts and reported a recommendation of approval to the City Council. On November 4, 2025, the City Council held a public hearing on said proposed amendment to the zoning ordinance and found and determined that said proposed change to the zoning ordinance is advisable, in the best interests of the City, and consistent with the Comprehensive Plan. The City Council further found and determined that public hearings were duly held and notices given. Therefore, the City Council hereby approves said proposed amendment to the zoning ordinance as set forth in this Ordinance.

<u>Section 2. Amendment to Zoning Ordinance</u>. Pursuant to Section 11.01 of the Springfield Zoning Ordinance, Section 4.14.09 is hereby amended to read as follows:

Section 4.14.09 Accessory Building and Uses

4.14.09 In the R-92, R-87, R-50, R-30 and RB Residential Districts, a maximum of two accessory structures shall be allowed. Swimming pools do not count towards the two accessory structure maximum.

- 1. Detached garages shall count as one accessory structure, with a maximum allowable size as follows:
 - Lots less than 13,000 square feet shall have a maximum allowable size of 720 square feet.

 Lots between 17,000-20,000 square feet shall have a maximum allowable size of 1,296 square feet.
 - Lots greater than 20,000 square feet shall have a maximum allowable size of 1,440 square feet.
- 2. Garden sheds shall count as one accessory structure, with a maximum allowable size of 144 square feet.
 - Section 3. Repeal Ordinances in Conflict. All other ordinances in conflict are hereby repealed.

<u>Section 4. Effective Date</u>. This Ordinance shall be in full force and effect from and after passage, approval and publication as provided by law.

Signing of the Year-End Certification of City Street Superintendent 2025

WHEREAS, State of Nebraska Statutes, sections 39-2302, and 39-2511 through 39-2515 details the requirements that must be met in order for a municipality to qualify for an annual Incentive Payment; and

WHEREAS, the State of Nebraska Department of Transportation (NDOT) requires that each incorporated municipality must annually certify (by December 31st of each year) the appointment(s) of the City Street Superintendent(s) to the NDOT using the Year-End Certification of City Street Superintendent form; and

WHEREAS, the NDOT requires that each certification shall also include a copy of the documentation of the city street superintendent's appointment, i.e., meeting minutes; showing the appointment of the City Street Superintendent by their name as it appears on their License (if applicable), their License Number (if applicable), and Class of License (if applicable), and type of appointment, i.e., employed, contract (consultant, or interlocal agreement with another incorporated municipality and/or county), and the beginning date of the appointment; and

WHEREAS, the NDOT also requires that such Year-End Certification of City Street Superintendent form shall be signed by the Mayor or Village Board Chairperson and shall include a copy a resolution of the governing body authorizing the signing of the Year-End Certification of City Street Superintendent form by the Mayor or Village Board Chairperson.

NOW, THEREFORE, BE IT RESOLVED by that the Mayor of the City of Springfield is hereby authorized to sign the attached Year-End Certification of City Street Superintendent completed form(s).

Agenda Item 5. Gottsch reviewed the two nuisance abatement letters sent to the owners of 285 N. 2nd Street in July and August. When the nuisances had not been abated, the Board of Health convened in September and declared the property a public nuisance as defined in Springfield Municipal Code §4-301 Nuisances; Specifically Defined. At the October Board of Health meeting, the board found that the nuisances had not been abated and subsequently directed the findings to be submitted to the City Council. Updated photos of the property were presented to the Council showing the property with appliances and other discarded items in the yard and grass and weeds with growth of more than 12" in height in the backyard. Motion by Neitzel, seconded by Murtha, to receive the report and all associated paperwork from the Springfield Board of Health regarding nuisances at Lots 3 and 4, Block 3, Springfield Addition to the City of Springfield, Sarpy County, Nebraska (285 N 2nd Street, Felici). AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 6. Motion my Herzog, seconded by Neitzel, to direct city staff to prepare cost estimates and/or obtain bids for nuisance abatement services at 285 N. 2nd Street. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 7. Gottsch obtained a proposal from Rick Hauptman with Hauptman Architecture to conduct an Urban Park Study to develop a conceptual site plan and canopy structure iterations. Hauptman worked with Alley Poyner Architecture prior to going out on his own. He was part of the team that designed the new elementary school and administration building. Previously, the city decided to construct a custom canopy structure at Urban Park. Murtha asked if there will be one design or a couple of options. Gottsch stated there will be a project committee to help develop the plans. Motion by Neitzel, seconded by Murtha, to approve the proposal from Hauptman Architecture, in the amount of \$135.00 per hour after pro-bono limit, not to exceed \$2,700.00, to conduct an Urban Park Study to develop a conceptual site plan and canopy structure interactions. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 8. Gottsch obtained a proposal from Rich Hauptman with Hauptman Architecture to conduct a Masterplan study of Springfield Memorial Library. Kallhoff asked if the masterplan study considered not just current needs, but future needs for increased attendance at programs. Gottsch noted that the plan will consider future needs. Motion by Murtha, seconded by Herzog, to approve the proposal from Hauptman Architecture, in the amount of \$135.00 per hour, not to exceed \$13,500.00, for the Masterplan Study of Springfield Memorial Library. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 9. Gottsch stated that Chris Woodman, Maintenance Manager, obtained bids from Bobcat and Leisure Life Sports to consider purchasing a larger UTV to be used by City Hall staff for local activities and during community events. Neitzel asked why a separate UTV was needed for community events. He asked why staff couldn't use the maintenance department's UTV or drive their personal vehicles. Herzog stated that the city's current UTV is 10 years old and questioned its remaining life. Neitzel asked if the existing unit would be traded in on the new one. Gottsch stated this new unit would be in addition to the

existing fleet. Andie Ledenbach, employee, stated that the current UTV does not have turn signals or windshield wipers. Murtha suggested that we look into a 4-seater golf cart. Motion by Herzog, seconded by Murtha, to table agenda item 9, regarding consideration of a bid for the purchase of a UTV for community events and City Hall staff use, until the November 18, 2025, Council meeting. AYES: Neitzel, Herzog, Murtha. NAYS: None. Absent: Craney. Motion carried.

Agenda Item 10. Gottsch stated that Woodman obtained a bid for the purchase of a 60" mower with bagger and roller kit. Neitzel asked if this is a new mower for Hwy 50. Gottsch stated that this would be used at the soccer complex and park properties. Neitzel asked why we need to purchase equipment for the soccer complex without a soccer program. Neitzel question what happened to the mower that was acquired when the city purchased the soccer fields. Gottsch stated that the old mower went to the well house. Neitzel question why we are keeping the fields in pristine condition without a program. Gottsch stated that SYAA is talking about starting a soccer program and there have been other associations in contact with the city, who are interested in the field as well. She noted that the city needs to figure out how the soccer complex will be managed and who will run it. Motion my Murtha, seconded by Herzog, to approve the bid from Ty's Outdoor Power & Service in the amount of \$19,563.66 for the purchase of a 60" mower with bagger and roller kit. AYES: Herzog, Murtha, Mayor Roseland. NAYS: Neitzel. Absent: Craney. Motion carried.

Department Reports

Agenda Item 1. Neitzel reported the water main project in the alley by the Post Office is coming along. Heath Shemek, Water/Sewer Operator, told Neitzel that there is a problem with the meter reading equipment, but that city staff is sorting through the issues.

Agenda Item 2. Herzog reported that the library is having their semi-annual book sale this Saturday.

Agenda Item 3. Murtha reported that the water is off in the park and the concession buildings are cleaned out. Tyler Holdorf, Parks Director, will be blowing out lawn sprinklers. Staff is working on wrapping garland on the poles on downtown Main Street for the holidays.

Agenda Item 4. No report from Craney.

Agenda Item 5. Mayor Roseland reported that the annual tree lighting event is on Monday, November 24.

Agenda Item 6. Gottsch reported that Council needs to determine how many hours of community service should be served by the juveniles that destroyed the communication board at City Park. Murtha suggested the juveniles also participate in an educational session focused on non-verbal people to learn why the communication boards are important. Kallhoff said that the juveniles could earn community service hours by helping to set up tables at the American Legion prior to their Big Red Dinners. A draft plan for pickleball at the Community Building was distributed. Gottsch stated that the electronic sign has been ordered, and she showed brick samples for the sign enclosure. Gottsch stated that November 24 is the annual Soup Supper, Making Spirits Bright Lighted Parade and Tree Lighting. She stated that the city will have a float in the parade and encouraged the Mayor and Council to join in the walk down Main Street. Gottsch stated that the downtown businesses Christmas open house is this weekend. Christmas music will be played over the PA system for the event. Murtha inquired about speaker hours. Gottsch reported that music is

playing from 9 a.m. to 8 p.m. on Sundays through Thursdays and 9 a.m. to 10 p.m. on Fridays and Saturdays.
