Regular Agenda

Agenda Item 1. Council reviewed the Sarpy County Sheriff's Monthly Service Report. Motion by Herzog, seconded by Craney, to move this agenda item later in the meeting to allow time for the sheriff to arrive. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 2. Deborah Armentrout, on behalf of the Springfield American Legion Auxiliary, requested permission to place a "Thank You Veterans" sign on the city's vacant lot at 1st and Main Streets. She said they would like to display the sign during the month of November for Veterans Day. Motion by Murtha, seconded by Neitzel, to approve the Springfield American Legion Auxiliary's request to place a "Thank You Veterans" sign on the city's vacant lot at 1st and Main Streets during the month of November. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 3. Ron Alexander, High School Principal and Athletic Director, said that the field condition at City Park has deteriorated. He noted that the field almost becomes unsafe to play on after a rain event because all of the agrilime product on the field runs off with a heavy rain. Travis Riley, Springfield Youth Athletic Association (SYAA), said that last year the SYAA added clay to the third base side to build

the field up. He noted issues with water running down from the parking lot onto the field. Ron obtained bids from two ball field companies, both with a different opinion as to what would improve the field condition. Ron said that the permanent solution would be to re-grade the entire field area; however, that would be very expensive (\$300,000+) and there could be utility issues with that type of project. Craney inquired about the school's commitment to continue utilizing the city parks for baseball and softball programs. Alexander noted that the school is committed to keeping the partnership going and it would be very difficult to pass a bond to build a new facility, especially when a facility already exists. Riley recommended obtaining a bid from the company that has been handling the field at Buffalo Park for the Legion. Mayor Roseland said that he would have a discussion about longevity with Dr. Ryan Saunders, Springfield Platteview School District Superintendent. Motion by Craney, seconded by Herzog, to table agenda item 3, regarding City Park infield drainage issues, until the October 19, 2021, Council meeting. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried.

Agenda Item 4. A Public Hearing of the Springfield City Council was opened at 7:30 p.m. to consider an application filed by the City of Springfield requesting a comprehensive plan amendment changing the future land use designation from Low Density Residential to Business Park on portions of properties legally described as Tax Lot 8A 23-13-11, Tax Lot 12A & 9 23-13-11, Tax Lot 1 & 4A1A & 11 23-13-11, 4A1B 23-13-11, Tax Lots 3 & 7 23-13-11, and Tax Lot 14 23-13-11, all in Sarpy County, Nebraska, and generally located approximately 500 feet west of Hwy 50 to 150th Street and north of Pflug Road to 1,300 feet south of Platteview Road. Staff reviewed the proposed changes. No one from the public spoke in favor of or in opposition to the proposed amendments. After all those wishing to speak were offered an opportunity to be heard, the Mayor recommended the hearing be closed. Motion by Craney, seconded by Herzog, to close the public hearing. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried. Public Hearing closed at 7:42 p.m.

Agenda Item 5. Council Member Craney introduced Ordinance No. 1077 entitled:

AN ORDINANCE TO CHANGE THE FUTURE LAND USE DESIGNATION FROM LOW DENSITY RESIDENTIAL TO BUSINESS PARK ON TAX LOT 8A 23-13-11, TAX LOT 12A AND 9 23-13-11, TAX LOT 1 AND 4A1A AND 11, 23-13-11, TAX LOTS 3 AND 7, 23-13-11, AND TAX LOT 14 23-13-11, ALL IN SARPY COUNTY, NEBRASKA; THESE PARCELS ARE GENERALLY LOCATED APPROXIMATELY 500 FEET WEST OF HWY 50 TO 150TH STREET AND NORTH OF PFLUG ROAD TO 1,300 FEET SOUTH OF PLATTEVIEW ROAD; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF

and moved that the statutory rule requiring reading on three different days be suspended. Council Member Murtha seconded the motion to suspend the rules and upon roll call vote on the motion the following Council Members voted AYE: Neitzel, Herzog, Murtha, Craney. The following voted NAY: None. The motion to suspend the rules was adopted by three-fourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. Said ordinance was then read by title and thereafter Council Member Craney moved for final passage of the ordinance, which motion was seconded by Council Member Murtha. The Mayor then stated the question "Shall Ordinance No. 1077 be passed and adopted?" Upon roll call vote, the following Council Members voted AYE: Neitzel, Murtha, Craney. The following voted NAY: Herzog. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor in the presence of the Council signed and approved the ordinance and the Clerk attested the passage and approval of the same and affixed her signature thereto and ordered the ordinance to be published or posted as required by law and as provided therein. A true, correct and complete copy of said ordinance is as follows:

ORDINANCE NO. 1077

AN ORDINANCE TO CHANGE THE FUTURE LAND USE DESIGNATION FROM LOW DENSITY RESIDENTIAL TO BUSINESS PARK ON TAX LOT 8A 23-13-11, TAX LOT 12A AND 9 23-13-11, TAX LOT 1 AND 4A1A AND 11, 23-13-11, TAX LOTS 3 AND 7, 23-13-11, AND TAX LOT 14 23-13-11, ALL IN SARPY COUNTY, NEBRASKA; THESE PARCELS ARE GENERALLY LOCATED APPROXIMATELY 500 FEET WEST OF HWY 50 TO 150TH STREET AND NORTH OF PFLUG ROAD TO 1,300 FEET SOUTH OF PLATTEVIEW ROAD; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA:

Section 1. APPLICATION. An application was filed by the City of Springfield, Nebraska, applicant, requesting a change of future land use designation from Low Density Residential to Business Park on Tax Lot 8A 23-13-11, Tax Lot 12A and 9 23-13-11, Tax Lot 1 and 4A1A and 11, 23-13-11, Tax Lots 3 and 7, 23-13-11, and Tax Lot 14 23-13-11; all in Sarpy County, Nebraska; these parcels are generally located approximately 500 feet west of Hwy 50 to 150th Street and North of Pflug Road to 1,300 feet south of Platteview Road.

Section 2. The City Council further found and determined that public hearings were duly held and notices were duly given. The City Council hereby approves said proposed change in future land use designation from Low Density Residential to Business Park on Tax Lot 8A 23-13-11, Tax Lot 12A and 9 23-13-11, Tax Lot 1 and 4A1A and 11, 23-13-11, Tax Lots 3 and 7, 23-13-11, and Tax Lot 14 23-13-11; all in Sarpy County, Nebraska.

Agenda Item 6. A Public Hearing of the Springfield City Council was opened at 7:44 p.m. to consider a conditional use permit application filed by Ready Mixed Concrete Co., applicant, and Lyman-Richey Corporation, a Delaware Corporation, successor-in-interest to Ready Mixed Concrete Co., a Nebraska Corporation, owner, for a concrete construction batch plant located at Tax Lot F2, Section 13, Township 13 North, Range 11 East of the 6th P.M. Sarpy County, Nebraska, generally located southeast of 138th Street and Fairview Road. Staff reviewed the operation and maintenance plan of the business, staff comments and key points of the conditional use permit agreement. Representatives of Ready Mixed

Concrete were present to speak in favor of their application, including Carol White, Real Estate Specialist, Tony Svoboda, Project Manager, and Grant Weaver, Environmental Specialist. Murtha inquired about the weight limit on 132nd Street and asked if the Fairview Road Bridge would be impacted by heavy trucks. Svoboda said that this bridge is rated for their truck loads. Svoboda estimated that this plant would produce 50,000-60,000 cubic yards per year. He said their Omaha facilities generate 200,000 per year. Council discussed dust control, road ingress/egress, floodplain permit requirements and length of permit. No one else from the public spoke in favor of or in opposition to the proposed amendments. After all those wishing to speak were offered an opportunity to be heard, the Mayor recommended the hearing be closed. Motion by Murtha, seconded by Herzog, to close the public hearing. AYES: Neitzel, Herzog, Murtha, Craney. NAYS: None. Motion carried. Public Hearing closed at 7:55 p.m.

AN ORDINANCE OF THE CITY OF SPRINGFIELD, NEBRASKA RELATING TO HIGHWAY SPEED LIMITS; AMENDING SPRINGFIELD MUNICIPAL CODE CHAPTER 5 TRAFFIC, ARTICLE 3 PROHIBITIONS AND

ENFORCEMENT, SECTION 5-319 AMENDING HIGHWAY SPEED LIMITS; TO HARMONIZE WITH STATE LAW; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, NEBRASKA:

Section 1. Chapter 5, Article 3, Section 5-319 of the Springfield Municipal Code is amended to read as follows:

§5-319 Highway Speed Limits.

No person shall operate a motor vehicle on any portion of Nebraska Highway 50 adjacent to the corporate limits of Springfield, Nebraska in excess of the following maximum limits:

- (1) On Nebraska Highway 50 from 750' south of Main Street to 1580' north of Platteview Road 50 miles per hour.
- (2) On Nebraska Highway 50 from 1580' north of Platteview Road to the north corporate limits, 160 feet south of Capehart Road 60 miles per hour.
 (Amended by Ord. No. 1078 10/1/21; Ord. No. 338, 4/2/91)

Section 2. Any other ordinance or code section passed and approved prior to passage, approval, and publication or posting of this ordinance and in conflict with its provisions is repealed.

Section 3. This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
