<u>Section 1. Application.</u> An application was filed by Danielle Lambries, applicant, and Constance L. and James K. Bertelsen, current property owners, and Randy Jacobsen, future property owner, requesting a change of zoning classification from R50 Two-Family Residential to Downtown Commercial on Lot 8 and the east 6 inches of Lot 7, Block 6, Springfield, Sarpy County, Nebraska; and generally located at 230 Main Street, Springfield, Nebraska.

Section 2. Approval to change the zoning classification from R50 Two-Family Residential to Downtown Commercial on Lot 8 and the east 6 inches of Lot 7, Block 6, Springfield, Sarpy County, Nebraska. On November 12, 2024, the Springfield Planning Commission conducted a public hearing on the matter of changing the zoning classification from R50 Two-Family Residential to Downtown Commercial and reported to the City Council that it recommended approval of the rezone. On November 19, 2024, the City Council opened a public hearing on said proposed changes and found and determined that the zoning classification from R50 Two-Family Residential to Downtown Commercial was advisable and in compliance with the Springfield Comprehensive Plan. ORDINANCE NO. 1164

AN ORDINANCE TO AMEND ARTICLE 5 "ZONING DISTRICTS", SECTION 5.05 AR AGRICULTURE RESIDENTIAL DISTRICT OF THE ZONING ORDINANCE OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA; TO REPEAL ORDINANCES IN CONFLICT; AND TO PROVIDE FOR THE EFFECTIVE DATE HEREOF.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SPRINGFIELD, SARPY COUNTY, NEBRASKA:

Section 1. Approval of Amendment to Zoning Ordinance. On November 12, 2024, the Springfield Planning Commission conducted a public hearing on the matter of amending Section 5.05 of the zoning ordinance to remove "publicly owned and operated buildings and facilities such as community centers, auditoriums, libraries and museums" from permitted uses and to remove "publicly owned and operated building and facilities such as community centers, auditoriums, libraries, museums, and privately owned non-commercial museums and historic areas" and "hospitals, nursing homes, and eleemosynary institutions" from permitted conditional uses and reported a recommendation of approval to the City Council. On November 19, 2024, the City Council held a public hearing on said proposed amendment to the zoning ordinance and found and determined that said proposed change to the zoning ordinance is advisable, in the best interests of the City, and consistent with the Comprehensive Plan. The City Council further found and determined that public hearings were duly held and notices given. Therefore, the City Council hereby approves said proposed amendment to the zoning ordinance as set forth in this Ordinance.

<u>Section 2. Amendment to Zoning Ordinance</u>. Pursuant to Section 11.01 of the Springfield Zoning Ordinance, Section 5.05 is hereby amended to read as follows:

Section 5.05 AR Agriculture Residential District

A. *Intent*. Provides for agriculture, low density residential development; minimum lot area of 5 acres, and interim uses under special conditions.

B. *Permitted Uses*

- 1. Agricultural farms, truck gardens, green houses, pasture, plant nurseries, orchards, grain storage facilities, and the usual agricultural farm buildings and structures
- 2. Single-family dwellings
- 3. Roadside stands offering for sale agriculture products produced on the premises
- 4. Church, seminary and convent, including residences for pastors and teachers
- 5. Public and parochial school; college
- 6. Publicly owned and operated buildings and facilities such as community centers, auditoriums, libraries, and museums
- 6. Fire Station
- 7. Public parks and recreation areas, playgrounds, forest and conservation areas, including commercial uses and campgrounds under franchise of the County or State government agencies
- 8. Private recreation areas and facilities, including lakes, ponds, country clubs, golf courses, and swimming pools
- 9. Public utility distribution systems, substations, terminal facilities, and reservoirs
- 10. Railroads
- 11. Irrigation facilities
- 12. Agricultural Processing as relating to a winery
- 13. Home occupations subject to Section 8.07

C. Permitted Conditional Uses

- 1. Cell/telecommunication towers
- 2. Airport
- Private and commercial kennels and facilities for raising, breeding, and boarding of dogs, and other small animals; provided all buildings and facilities are at least 100 feet from any property line, and 300 feet from any residential zoning district

- 4. Extraction and processing of rock, gravel, sand, clay, and dirt
- 5. Temporary trailer
- 6. Commercial recreational areas including facilities for fishing, shooting, hunting, auto racing, cycle clubs, bridal clubs, etc.
- 7. Commercial camping areas
- 8. Publicly owned and operated buildings and facilities such as community centers, auditoriums, libraries, museums, and privately owned non-commercial museums and historic areas
- 9. Hospitals, nursing homes, and eleemosynary institutions
- 8. Billboards
- 9. Signs
- 10. Private barns, and associated livestock, for not more than one (1) animal for the first acre of land, and one (1) additional animal for every two (2) additional acres of land
- 11. Planned Development District
- 12. Satellite dish antennas that conform to the supplementary regulations of this Ordinance
- 13. Child care home
- 14. Licensed Recreational Vehicle Storage- Out of Doors and/or Within an Enclosed Building
- 15. Unlicensed Recreational vehicle Storage Within and Enclosed Building
- 16. Bed and Breakfast
- 17. Concrete recycling and distribution plant
- 18. Alternative Energy Production (Ordinance No. 1055, 11/17/2020)
- 19. Concrete Construction Batch Plant (Ordinance No. 1066, 6/1/2021)

Section 3. Repeal Ordinances in Conflict. All other ordinances in conflict are hereby repealed.

<u>Section 4. Effective Date</u>. This Ordinance shall be in full force and effect from and after passage, approval and publication as provided by law.
