- 4. Motion by Webster, 2<sup>nd</sup> by Skorcz, to approve the meeting agenda. Ayes: Webster, Skorcz, Kulm, Opitz, Fisher, Chartier. Nays: None. Motion carried.

Opitz inquired if building codes would be monitored and enforced. Andie Ledenbach, Planning Commission Clerk, stated that building permits would be required for any changes made and Sarpy County would be inspecting and subsequently approving all changes.

The Planning Commission inquired if adequate parking would be provided for customers. Ledenbach remarked that Jeff Ray, JEO City Planner, approved the site for parking and commented the location of the business has access to the city's public parking spaces in the area. Skorcz commented that the city will need to be aware of plowing the alley for customers.
